

Dear Kingstream Residents,

The Kingstream Pool Committee will again be using the notebook system of residents' pictures to validate access to the pool this season. All residents who wish to use the pool must have their Pool Access Verification form (PAV) with photos on file in the notebook in order to gain access to the pool.

Residents who have their PAV form on file need not submit anything further in order to be granted access to the pool. However, any households where there has been a change in the number or names of residents, or whose phone number has changed must update their form by coming to the pool and making the changes on their existing PAV form. Additionally, homeowners new to the neighborhood since the previous pool season must also submit their new PAV form/photos. Note that all homeowners must have fully paid their annual community dues to RCS Management by the pool opening date in order to gain access to the pool.

When you arrive at the pool for the first 1-2 weeks, please provide the guard with your last name as you enter. The lifeguards will verify your name/photo in the notebook to ensure those entering are paid Kingstream residents. We appreciate your patience and cooperation during this time. Always write your name/time on the log sheet. Once the lifeguards get to know the faces of our members, they will be able to wave you through without having to check your status each time. You will still be required to sign in/out using the log sheet each time you enter/exit the pool. If your PAV form is not in the notebook, this means you are either new to the community and/or you have an outstanding balance with RSC Management and will need to contact rod@rcsmanagement.org 703-778-7271 before pool access is granted.

Our pool access system also includes a provision for guests. Members may purchase guest books (6 passes per book) for \$15 each (payable by check only to KCC). No cash will be accepted. Members may pay for an individual guest for \$3 per person as they enter the pool (check only). Guest passes will be kept with your PAV form in the notebook at the pool clubhouse and lifeguards will punch the passes for each guest brought by a member. Guest passes left over from last year will be available for use this summer.
